The articles are suitable for contact with the all types of food under the intended and foreseeable conditions of use.

General EU compliance:

The articles comply with the relevant requirements of 1935/2004/EC, as amended, Article 3, 11(5), 15 and 17, and 10/2011/EU, as amended, and are manufactured in compliance with 2023/2006/EC, as amended.

The articles also comply with the Danish regulation BEK. No. 681 of 25/05/2020.

Specific EU compliance:

Only authorized monomers, other starting substances, macromolecules obtained from microbial fermentation, additives, and polymer production aids, specified in Annex I of 10/2011/EU, as amended, have been used.

The articles do not contain any substances for which restrictions or purity criteria are in place in accordance with Regulations 1333/2008/EC and 1334/2008/EC, as amended.

FDA compliance:

The articles comply with US-CFR Title 21, Chapter 3, §177.1520, Olefin polymers

The articles are intended for transporting and holding foods, for up to 2 hours at temperatures up to 70 °C. The articles have been tested for 2 hours at 70 °C (OM3), as specified in 10/2011/EU, with a volume to surface ratio of 47-55 ml/dm².

The overall migration results for food simulants A, B, or D2 of <2 mg/dm² (<12 mg/kg) comply with the overall migration limits of 10 mg/dm² (60 mg/kg).

The products covered by this DoC contains the following substances for which restrictions and/or specifications are set out in Annexes I and/or II of 10/2011/EU:

1-octene

Specific migration < 0.1 mg/kg

SML: 15 mg/kg

Substance A

Specific migration <6 mg/kg

Compliance with specific migration limits (SML) have been documented through testing under OM3 conditions. The substances will not migrate in quantities that will exceed the SML under the specified conditions of use.

Migration tests were performed by an ILAC-MSA certified external test laboratory on behalf of the distributor and in compliance with 10/2011/EU and 752/2017/EU as amended.

SBK A/S is registered with the Danish Veterinary and Food Administration (DVFA), and our mandatory Own Control System is subject to inspection by the DVFA.
